



SUBJECT: Reassignments

This memorandum serves as notification to the union that the Assistant Secretary for Single Family Housing will reassign the employees (list attached), effective Sunday, July 17, 2011. The reassignments are made based on the following:

- FHA's Market share has gone from 3% to over 30%. The Liaison Program was established to strengthen FHA's relationship with our industry partners, the FHA lenders, real estate professionals, builders, housing counselors, and national and local trade associations. We are now at a point where these individuals can be reassigned into the ranks of the Homeownership Centers (HOCs) and take on an even greater role in assisting the Agency to meet its goals and objectives.
- The long term goal of the account liaison program was to strengthen FHA's business relationship with our industry partners in making FHA a valued business partner and financing option of choice regardless of market conditions.
- The Homeownership Centers have experienced significant turnover in their ranks since the beginning of the 2011 fiscal year and have been unable to back fill those positions. Therefore, reassigning the account liaisons will greatly assist the HOCs in meeting their goals and objectives.
